Subject: Special Reinstatement and Restoration Campaign

The Most Worshipful Prince Hall Grand Lodge of Free and Accepted Masons of North Carolina and Jurisdiction, Inc. conducts a Special Reinstatement and Restoration Campaign from 01 February 2024 to 01 August 2024. The associated fee for this campaign is \$85 for reinstatements and \$85 plus \$12 per year of unaffiliated/unfinancial status for restorations.

The process for this campaign is:

- Submission of National Background Check
- Adjudication of National Background Check
- Issuance of Application for Reinstatement or Restoration (after favorable adjudication)
- Investigation Committee, Recommendation to Lodge, Lodge Vote (2/3 required)
- Submission of Supplemental Report

The itemization of the \$85 fee is:

- National Background Check - \$25
- Grand Lodge Taxes - \$30
- Lodge Reinstatement/Restoration Tax - \$30

Restorations include a fee of \$12 per year brother was not financial.

- 1 year - \$85 + \$12 = \$97
- 2 years - \$85 + \$24 = \$109
- 3 years - \$85 + \$36 = \$121
- 4 years - \$85 + \$48 = \$133
- 5 years - \$85 + \$60 = \$145
